#### The First Workshop of 2024

The first workshop of this year, titled "Antiparasitic Veterinary Drugs: From the Bench to the Market Crossing (Carefully) the Environment", took place on December 12, 2024. Organised by WG3, led by Guy Caljon with the support of Jose Alunda, the workshop provided an in-depth exploration of veterinary medicines regulation in Europe, including the framework, regulatory agencies, and marketing authorisation processes.

Discussions also covered the development of promising veterinary medicine candidates and the mechanisms available at EMA and AEMPS to support innovation, particularly for SMEs. A key focus was the European approach to environmental risk assessment of veterinary medicines, highlighting prospects and challenges.














## Year 3 OneHealthDrugs Marathon, held in November

For the next 3rd period, the allocated budget will allow about **10 STSM, 2 Dissemination grants**, with 2 rounds of selection.

The STSM application windows are:

- 15 October-30 November 2024
- 1 February 15 March 2025


All STSM and grants must be completed by end of August 2025, to have the time to report and be reimbursed by end of September 2025. In the evaluation process YR have priority, even if senior scientists are welcome to apply. Additional requirements will be included for approval that is the integration of drug research fields with environmental impacts outcome and declaration of the Global development goals explicitly addressed. These requirements will apply starting from the 6th STSM calls.

From this year onwards we have additional Dissemination grants:


- YRI Conference grant funds a presentation (poster/oral presentation) of their own work by a Young Researcher and Innovator (YRI) in a high-level conference fully organized by a third party, i.e. not organized nor coorganized by the COST Action.
- ITC Conference grant funds an oral presentation of their own work within the scope of the Action by an Action Participant affiliated to a legal entity located in an Inclusiveness Target Country / Near Neighbor Country in a high-level conference fully organized by a third party, i.e. not organized nor co-organized by the COST Action.
